Money-earning activities should be valuable program opportunities for girls. The following requirements must be met in planning any money-earning activity.

1. Any troop/group money-earning activity (except council sponsored product program) **MUST** have the prior written approval of the council.
2. All *Safety-Wise* standards (see pp.74-76 and 29, 2000 Edition) must be met.
3. Daisy Girl Scouts and their parents do not participate in troop money-earning activities or council sponsored product program.
4. Troops/groups which do not participate in council product sales, will not be allowed to conduct other money-earning activities.
5. Girl Scout sponsored product programs are the only commercial products which may be sold.
6. Troops/groups may not approach business or merchants for donations or discounts.
7. Other money-earning activities may not be conducted during council sponsored product programs.
8. Money earned belongs to the troop and is not the property of individual girls.
